ORDER:

The Hon'ble Minister (Health and Family Welfare) has made an announcement on the floor of Tamil Nadu Legislative Assembly for the year 2020–2021 as follows:-

"Orphan and Vulnerable Children Corpus Funds of Tamil Nadu trust for the children affected by HIV/AIDS (TNTCAA) will be increased at a cost of Rs.10 crores. The interest funds generated under the trust can be utilized for education and notional support for Orphaned and Vulnerable Children".

- 2. In the Government order first read above, orders have been issued constituting a trust in the name of "Tamil Nadu trust for the children affected by HIV/AIDS (TNTCAA)" and sanction has also been accorded for a sum of Rs.5.00 crore (Rupees five crore only) towards the Government's contribution to the Tamil Nadu Trust for children affected by HIV/AIDS (TNTCAA).
- 3. In the Government order second and third read above, sanction has been accorded to provide additional financial assistance of Rs.5.00 crore (Rupees five crore) in addition to the existing corpus fund to the Orphaned and Vulnerable

Children Trust for Children affected and infected by HIV/AIDS. The Government also direct that the above said amount will be deposited in the Power Finance Corporation along with the old corpus fund.

4. The Project Director, Tamil Nadu State AIDS Control Society has stated that the Government of Tamil Nadu have sanctioned three equal installment of Rs.5.00 crore each (totally Rs.15.00 crore) to the HIV/AIDS affected / infected children by forming trust with 11 Trustees under the chairmanship of the Secretary to Government, Health & Family Welfare Department to help children who lost either their mother or father or both due to AIDS. Tamil Nadu State AIDS Control Society receives nearly 15.750 applications annually through the District units and out of which only 3828 (45%) of children are being covered from the accrued interest amount of Rs. 15.00 crore. The trust provide educational, medical, recreational and economic assistance to children and adolescents (aged 1 day to 18 years). Further in this financial year (2020-2021), a data enumeration is in process at the district level through the respective District AIDS Prevention and Control Units (DAPCUs) by creating an on-line web portal software solution so as to identify the needy children and also to avoid duplications. This exercise may widely cover the children who are presently under going higher educational studies such as (Professional Curriculums, UG / PG Colleges, Diploma / Polytechnic courses) and they are also in need of annual financial support of more than @ Rs.5000/- each for their Education & Nutritional supplements. Therefore, there is a need to increase the number of children beneficiaries, the corpus to Tamil Nadu trust for the children affected by needs to be increased from Rs.15.00 crore to HIV/AIDS (TNTCAA) Trust Rs.25 crore. The Trust (TNTCAA) will grant for these children based on their age and educational level as per the operational guidelines. The number of beneficiaries of Orphaned and Vulnerable Children who have been supported during the past nine years' (i.e.) since from the commencement of this scheme, as detailed below:-

5. The Project Director, Tamil Nadu State AIDS Control Society has stated that the majority of Child beneficiaries receive financial support for education, and others receive support of nutrition, medical and socio-economic needs. Ail those children who were supported are orphaned (lost one or both parents) or are being infected or affected by HIV/AIDS or even with single parent infection. The children receive grants ranging from Rs.2,000 /- to Rs.3,000 /- based on their Age & Educational standard at school, and the support will continue till they complete 18 years of age.

- 6. The Project Director, Tamil Nadu State AIDS Control Society has stated that the total additional corpus fund of Rs.10.00 crore is required for the Tamil Nadu trust for the children affected by HIV/AIDS (TNTCAA) Trust, so as to enhance the funding pattern of Rs.3,000/- to Rs.6,000/- against the funding pattern of Rs.2,000/- to Rs.3,000/- (except Chennai) and also to increase the coverage of financial assistances to nearly 5850 to 6000 number of children from the accrued interest from the corpus fund which will enhance their quality of life by supporting for their Educational and Nutritional needs.
- 7. The Project Director, Tamil Nadu State AIDS Control Society has requested the Government to sanction an Additional Corpus fund of Rs. 10.00 crore (Rupees ten crore only) to the Tamil Nadu Trust (TNTCAA) for the children Affected by HIV/AIDS (TNTCAA) in helping the Children Living with & affected by HIV/AIDS to lead a better life.
- 8. The Government after careful examination of the request of Project Director. Tamil Nadu State AIDS Control Society have decided to accept the same and sanction has been accorded to provide additional Corpus fund of Rs. 10.00 crore (Rupees Ten Crore only) to the Tamil Nadu Trust for the children affected by HIV/AIDS (TNTCAA) in helping the Children living with & affected by HIV/AIDS to lead a better life and to deposit the amount in Power Finance Corporation along with the old Corpus Fund.
- The amount sanctioned in para 8 above shall be debited to the following Head of Account:-

"2251-00-Secretariat Social Services – 090- Secretariat – State's Expenditure JE Government's contribution to the Trust for Children Orphaned / affected by AIDS – 309 – Grants-in-aid-03-Grants for Specific Scheme"

- 10. The expenditure sanctioned in para 8 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Secretary to Government, Health and Family Welfare Departments is directed to apply for sanction of advance from the Contingency Fund to Finance (BG-I) Department directly in Form. A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Order for sanction of an advance for the Contingency Fund will be issued from Finance (BG-I) Department. The Secretary to Government, Health and Family Welfare Departments is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2020-2021 to Finance (BG-I/Health-I) Department without fail.
- The Section Officer (Bills), Health and Family Welfare Department is authorized to draw and disburse the amount to the Project Director, Tamil Nadu State

AIDS Control Society by means of a Cheque drawn in favour of the Project Director, Tamil Nadu State AIDS Control Society.
